

MTA's One Year of Free Internet Service Giveaway Rules

OFFICIAL RULES

SPONSOR: The Promotion is sponsored by Matanuska Telecom Association (MTA). This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook. You are providing your information to MTA and not to Facebook.

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. Odds of winning depend on the number of entries received.

GIVEAWAY ENTRY PERIOD: Giveaway starts on 12/01/2022 and ends at 11:59:59 PM AKDT on 12/30/2022.

ELIGIBILITY: The Giveaway is open to legal residents of Alaska age 18 or older at the time of entry. Employees of MTA ("Sponsor") and their respective subsidiaries, affiliates, advertising and promotion agencies and marketing/prize providers, and the immediate family members of, and/or those living in the same household ("Household members") of each, are not eligible to enter. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses, regardless of where they live. Existing Customer Eligibility (to receive one month of upgraded internet and be entered to win a year of free internet): Must be a current customer of MTA. May not have any withstanding debt or a past due balance to MTA and must ensure that account information is accurate and up to date. After the Credit Period(s) ends, customers will automatically be charged the then-current monthly price of their subscription. Customers may cancel service at any time by calling 907-745-3211 or visiting one of our retail stores.

If the Winner disconnects their internet service during the 1- Year Free Internet, they are no longer eligible for the 1-Year Free Internet credit and therefore any remaining credits associated with this Prize will be forfeited.

ENTRY: During the Giveaway Period, eligible individuals (“Entrants”) may enter the Giveaway by signing up for a free 1-month trial of a *select* MTA Unlimited Internet plan OR if Entrant is already an existing MTA customer, by signing up for a free 1-month trial of an upgraded MTA Internet Plan (MTA will upgrade you to Unlimited if currently on a capped plan, and to the fastest speed made available to your household without requiring a Truck Roll). MTA will provide the fastest possible speed available to the winner, as well as providing unlimited data usage The [Internet Service Agreement](#) and [Website Terms of Use](#) apply (“MTA Terms of Use”).

Estimated retail price: Between \$1,320 - \$2,280 (depending on available speed)

PRIZE DRAWING: The winner will be randomly selected from all eligible entries received during Giveaway Period. The winner shall be notified by email and have 24 hours to reply in order to redeem the prize before the selection of the new winner.

Drawing will take place at the offices of the Administrator; whose decisions are final. Prize award is subject to verification of eligibility and compliance with these Official Rules.
