

## MTA's Skeetawk Sweepstakes

### OFFICIAL RULES

**SPONSOR:** The Promotion is sponsored by Matanuska Telecom Association (MTA).

**SWEEPSTAKES ENTRY PERIOD:** Sweepstakes starts on 1/09/2023 and ends at 11:59:59 PM AKDT on 1/26/2023.

**ELIGIBILITY:** The Sweepstakes is open to legal residents of Alaska age 18 or older at the time of entry. Employees of MTA ("Sponsor") and their respective subsidiaries, affiliates, advertising and promotion agencies and marketing/prize providers, and the immediate family members of, and/or those living in the same household ("Household members") of each, are not eligible to enter. **PRIZE DRAWINGS:** Winners will be randomly selected at the end of the sweepstake from all eligible entries received during Sweepstakes Period. Winners shall be notified by email and have 24 hours to reply in order to redeem prize before selection of new winner.

Drawing will take place at the offices of the Administrator whose decisions are final. Prize award is subject to verification of eligibility and compliance with these Official Rules.
